## How to request a regulatory history form/equivalent letter from HCPC, CORU, AHPRA, and some jurisdictions within India

- If you worked in the NCT of Delhi or were registered since 2003 you must provide a regulatory history form or its equivalent. Use the CPTBC regulatory history form/equivalent and request the completed form/letter be emailed to [registration@cptbc.org](mailto:registration@cptbc.org)

Notes:

Some regulators/authorities/jurisdictions/councils/federations charge a fee to issue a letter or complete a form. You must settle directly with the regulator before they will complete the document.

Some regulators/authorities/jurisdictions/councils/federations require your registration to be current and any outstanding fees or fines must be settled.

Regulatory history form, good standing letter, registration confirmation, or registration verification letters are considered equivalent documents.
