

Registration & Jurisprudence Exam

- Does the College accept the NBEO? Yes, we accept successful completion of the NBEO (I, II, III) as equivalent to the OEBC.
- 2. How long are Registration Applications valid? Registration Applications are valid for one year from the date the application is received by the College office.
- 3. When is the deadline for submission? There is no deadline for submission. Registration Applications are accepted all year round.
- 4. If an application is withdrawn, is any portion of the fee refundable? No portion of the fee is refundable.
- 5. What if the requirements change after my application is submitted? Registration Applications will be reviewed under the regulations in effect at the date the application is received by the College.
- 6. Can an application be notarized outside of BC? Yes, you may have your application notarized outside of BC by a lawyer, notary public or other commissioner for taking oaths. Please ensure that any notarized documents are signed, dated and stamped with the seal of the lawyer, notary public, or other commissioner.
- 7. When should a Letter of Good Standing (Certificate of Standing) be submitted? Letter of Good Standing must be dated no more than 30 days before your BC Registration Number is issued.
- 8. How do I complete the Criminal Record Check through the Criminal Records Review Program (the CRRP)?

To complete a criminal record check through the CRRP, send your request to the College through the <u>Contact Us</u> form. The College will provide you a secure link with an access code that will direct you to the online criminal record check application.

 What do "OT" and "TMOD" mean? OT – refers to Ocular Therapeutics is a component of the CACO/CSAO/OEBC. TMOD – refers to Treatment and Management of Ocular Disease is a component of the NBFO.



10. Can I take the Jurisprudence Exam prior to finishing my OD program? While waiting for my OEBC/NBEO exam results? No, you must meet all registration requirements before taking the Jurisprudence

11. Where and how often is the Jurisprudence Exam administered?

The Jurisprudence Exam is administered online and will be offered to applicant whose registration application is received and deemed acceptable by the College.

12. How long does it take to get the Jurisprudence Exam results? As the Jurisprudence Exam is being administered online, the results will be available right after completing the exam.

13. How soon will my registration be active?

After completing all the requirements for registration including the annual registration payment, your BC registration number and package will be sent to you via email.

14. How do I obtain a Letter of Good Standing from CHCPBC?

To obtain a Letter of Good Standing , send your request to the College through the <u>Contact Us</u> form, specifying your name, profession, registration number and who you would like it sent to. Please be advised there is a fee for Letter of Good Standing, as set out in <u>Schedule 1, S.4.0</u> of the <u>College Bylaws</u>. Note: There is a College policy in place that states that the issuance of a Letter of Good Standing may take up to 20 business days to process.
