Policy Statement:

A Full Registrant of the Designated Health Profession of Physical Therapy (a "Registrant") must apply to the College prior to performing dry needling in their practice. An annotation will be added to the Registrant's entry on the public register upon approval of the application by the College.

A Registrant seeking to perform dry needling must:

- Be a Full Registrant in good standing with the College, and
- Have at least two years of physical therapy practice experience and a minimum of 3,900 practice hours, and
- Have successfully completed a course listed in Appendix A, and
- Submit an application form and any related documents, as determined by the College.

1. Policy Rationale and Purpose:

Physical therapists have been performing dry needling in BC since before physical therapy was designated as a regulated profession in the province. Although this treatment is not currently prescribed in the Physical Therapists Regulation, the College regulates the practice by policy and standards of practice.

2. Policy Scope:

This policy applies to Registrants of the Designated Health Profession of Physical Therapy in the registration class of Full.

Dry needling – A treatment technique that uses solid filament needles to puncture the skin for therapeutic purposes; includes a range of approaches, such as acupuncture, trigger point dry needling and intramuscular stimulation
