

## **PUBLIC NOTICE**

## Daljodh Khaira, RPT

Location: Surrey, BC

Effective November 28, 2024

Date of Action Ended: August 27, 2025

Limits, conditions and suspensions ordered by the Inquiry Committee under section 35(1) of the Act, or by the Discipline Committee under section 38(8), are made to protect the public during an investigation, pending a hearing, or during a hearing. Measures taken under sections 35(1) or 38(8) of the Act pertained to matters which are and remain unproven unless admitted by a registrant or determined by the Discipline Committee. Actions under sections 35(1) and 38(8) of the Act are subject to appeal by the registrant to the court

**Update:** On completing its investigation into this matter, the Inquiry Committee determined that these limits/conditions were no longer necessary to protect the public and cancelled the interim order on August 27, 2025.

**Nature of Action**: On August 29, 2024, the College of Health and Care Professionals of BC (the "College" or "CHCPBC") received a complaint alleging that Daljodh Khaira, RPT (the "Registrant") committed boundary violations and engaged in sexual misconduct by initiating, entering into and maintaining an intimate relationship with a female patient over a prolonged period of time. The complaint is currently under investigations and the allegations are **unproven**.

On November 28, 2024, the Inquiry Committee made an order<sup>1</sup> imposing the following interim limits or conditions on the Registrant's practice for the purpose of protecting the public while the matter is under investigation:

- The Registrant may not treat female patients.
- The Registrant must immediately post a notice, in a prominent position, on all online booking pages associated with the Registrant the following statement: Daljodh Khaira, RPT is prohibited from treating female patients, by order of the Inquiry Committee of the College of Health and Care professionals of British Columbia, dated November 28, 2024. - The Registrant must also post in a prominent place in any treatment room where he provides physical therapy treatment, a notice that is printed on 8 x 11 inch paper and in large font stating in English: Daljodh Khaira, RPT is prohibited from treating female patients, by order of the Inquiry Committee of the College of Health and Care professionals of British Columbia, dated November 28, 2024. The order is available on the College website at: <a href="https://www.chcpbc.org">www.chcpbc.org</a>.
  - The notice is only required to be posted in the treatment room when the Registrant is treating a patient.
- The Registrant must, by 6:00 p.m. every Friday, while these limits or conditions are in effect, provide the College with, or electronic access to, the Registrant's calendar, including the name and contact information for each patient he treated in the preceding week.
- The Registrant will be subject to random on-site audits of his practice by a College-appointed inspector to ensure compliance with the order, with the frequency and timing of the random on-site audits to be at the sole discretion of the College.
  - Without limiting the foregoing, an inspector may inspect any patient booking-process (whether that occurs physically, by telephone, or otherwise electronically) and any file or record of any patient treated by the Registrant.

The order came into effect on November 28, 2024, and will terminate on the day that the Inquiry Committee resolves the complaint under section 33(6)(a), (b) or (c) of the Health Professions Act or on the commencement of any hearing of the College's Discipline Committee with respect to the complaint.
